Architectural Change Requests (ACR)

Do you want to plant flowers? Do you want to replace or

add a storm door? Do you want to add mulch, rocks, trim, outdoor lights, etc.? That's great, but please remember, as condo owners, we do not own anything outside our units; the Association owns it. Our Covenants require that changes made by owners outside units be pre-approved by the Board. If you want to change anything about the exterior of your unit, you MUST fill out an ACR request on the Covengton website. Making a change that is not pre-approved, may result in a violation letter, the chance to have a hearing, and a possible fine that will be added against your account. Please submit ACR requests before making any changes!

Reserve Study Update

The reserve study discussed in our February Homeowners' Meeting is complete! The Board has been reviewing the study and prioritizing capital improvements that will need to be done in the coming years to keep Covengton in top shape! Garbage & Recycling: Please make sure to put your trash *inside* the dumpster. Also, it helps save space if you break down your boxes before placing them in the recycle bin.
